THE FOLLOWING INFORMATION IS PROVIDED TO COMPLY WITH THE REQUIREMENTS OF THE GENERAL DATA PROTECTION REGULATIONS.

Whiteoak Morris Limited is dedicated to ensuring the protection of your personal information. This privacy notice explains how we use any personal information we collect about you, in accordance with the General Data Protection Regulations ("the regulations"). This privacy statement describes why and how we collect and use personal data and provides information about individuals' rights. It applies to personal data provided to us, both by individuals themselves or by others. We may use personal data provided to us for any of the purposes described in this privacy statement or as otherwise stated at the point of collection.

IDENTITY AND CONTACT DETAILS OF THE CONTROLLER AND WHERE APPLICABLE, THE CONTROLLER'S REPRESENTATIVE AND THE DATA PROTECTION OFFICER

Where an insolvency practitioner of Whiteoak Morris Limited is appointed as office holder and the data processing is carried out as part of their statutory duties, the appointed insolvency practitioner is the data controller. For the purpose of the Data Protection Legislation and this notice, we are the 'data controller'. This means that we are responsible for deciding how we hold and use personal data about you. HOW WE USE YOUR PERSONAL INFORMATION

Prospective Clients

Debtors

Your name, company name, job title, address and contact details, including email address and telephone number, date of birth and gender;

Prospective Employees

Your name, company name, job title, address and contact details, including email address and telephone number, date of birth and gender, the terms and conditions of your employment;

HOW WE USE THE INFORMATION COLLECTED

We collect information about you to answer your questions or deal with your request for advice. In addition, the information is used to manage any matters we may be dealing with which you may be connected to. Information is also processed if you are looking for employment with us. We consider these to be lawful reasons for using the information we collect about you.

In processing your request for advice, we may send and receive information about your personal details from credit reference agencies and fraud prevention agencies.

WHO WE SHARE OUR DATA WITH

This cookie was also used for the deprecated <u>setVar</u> method. The cookie is updated every time data is sent to Google Analytics.

Cloudflare

The __cfduid cookie is used to identify individual clients behind a shared IP address and apply security settings on a per-client basis.

For example, if a visitor is in a coffee shop where there may be several infected machines, but the specific visitor's machine is trusted (for example, because they completed a challenge within your Challenge Passage period), the cookie allows Cloudflare to identify that client and not challenge them again. It does not correspond to any user ID in your web application, and does not store any personally identifiable information.
